Consideration of the categorical exemption #20 and amendments to the spheres of influence for the El Dorado County Fire Protection District and the El Dorado Hills County Water District.

5. PUBLIC HEARING TO CONSIDER THE ENVIRONMENTAL REVIEW AND THE MARBLE VALLEY REORGANIZATION TO EL DORADO IRRIGATION DISTRICT, EL DORADO HILLS CSD, EL DORADO COUNTY FPD AND EL DORADO HILLS CWD (LAFCO PROJECT NO. 05-08)
