# 7. PUBLIC HEARING TO RECONSIDER THE ENVIRONMENTAL REVIEW AND THE SHINGLE SPRINGS RANCHERIA REORGANIZATION TO THE EL DORADO IRRIGATION DISTRICT (LAFCO PROJECT NO. 2012-04)

Reconsideration of the Commission's approval of the concurrent detachment and re-annexation of the Shingle Springs Rancheria (APN 319-100-37, 159 acres), to provide services to the affected territory reflecting current land use and development conditions, consistent with a 2008 MOU between EID and the Shingle Springs Band of Miwok Indians. The person/group requesting reconsideration is also requesting a waiver of LAFCO fees associated with the reconsideration request.

**Recommended Action:** Staff recommends the denial of request for a reconsideration fee waiver and denial of the reconsideration request

Informational study on the South Tahoe Public Utility District and an analysis of its service provision capabilities. The recommended sphere of influence, based on the findings of the MSR, is also included in the report. The Commission considered a draft version of the report and opened the public comment period at the August 22, 2012 meeting.

**Recommended Action:** Open the public hearing and adopt the recommended SOI.

# 9. PUBLIC HEARING TO CONSIDER AND ADOPT A RESOLUTION OF INTENTION TO APPROVE A CONTRACT BETWEEN EL DORADO LAFCO AND THE CALIFORNIA PUBLIC RETIREMENT SYSTEM

Since 2004, El Dorado LAFCO has participated in CalPERS' retirement system since the agency became independent of El Dorado County; albeit, under a combination of the County's employer code and LAFCO's own office code. CalPERS' new automated system no longer recognizes office codes, making it necessary for LAFCO to have its own contract, which it approved in December 2012. Due to a technicality, LAFCO must go through the steps to approve the contract once again

**Recommended Action:** Open the public hearing on this matter and adopt a resolution of intention to approve the new CalPERS contract
