4. CONDUCTING AUTHORITY PROTEST HEARING FOR THE ENVIRONMENTAL REVIEW AND THE MEEKS BAY FIRE PROTECTION DISTRICT ANNEXATION OF RUBICON BAY PARCELS AND EMERALD BAY TRACTS (PROJECT NO. 2010-04)

Conducting Authority proceedings to accept landowner protests for the Meeks Bay Fire Protection District Annexation of Rubicon Bay Parcels and Emerald Bay Tracts; LAFCO Project No. 2010-04. The annexation was initiated by the Meeks Bay Fire Protection District and includes 29 parcels (40.25 acres); APNs 016-600-07, 016-600-08, 016-600-10, 016-600-13, 016-600-19, 016-600-20, 016-600-21, 018-020-03, 018-020-04, 018-020-05, 018-020-06, 018-020-07, 018-020-08, 018-020-09, 018-020-10, 018-020-11, 018-030-01, 018-030-02, 018-030-03, 018-030-04, 018-030-06, 018-030-07, 018-030-08, 018-030-09, 018-030-10, 018-030-11, 018-030-12, 018-030-13 and 018-030-14. The properties are located in the northeastern portion of El Dorado County in two separate annexation areas: west of Rubicon Bay, southwest of the intersection of State Highway 89 (Emerald Bay Road) and Scenic Drive; and northwest of Emerald Bay near the intersection of State Highway 89 (Emerald Bay Road) and Upper Emerald Bay Road. The annexation was approved by the Commission at the April 27, 2011 LAFCO meeting.

Recommended Action: Summarize the Commission's Resolution Number L-2011-06 making determinations, open the Conducting Authority proceedings for the Meeks Bay Fire Protection District Annexation of Rubicon Bay Parcels and Emerald Bay Tracts, accept all valid landowner protests, authorize the Executive Officer to determine the value of written protests filed and adopt Conducting Authority Resolution L-2011-08, ordering the annexation if no majority land value protest is received.
