## **MINUTES OF SEPTEMBER 25, 2013**

Commissioner Laine expressed her concern that it is a difficult balance for the Commission, who has to represent the taxpayers and its staff. She stated that the writing is on the wall and it is being seen across the state and across the nation with these negotiated contracts. Basically, LAFCO employees benefitted from other unions that negotiated the benefits with sister agencies and then the Commission accepted these benefits when LAFCO went its own way. She added that she believes the Commission needs to move in the direction of employees paying their share and find a way to do that without hurting the employees financially. She thought the way for the Commission to move is to set in place a better way.
