Annexation of 14.66 acres (APNs 062-230-06, 062-230-09, 062-230-10, 62-390-36, 062-390-41 and 062-390-46) into the Georgetown Divide Public Utility District (GDPUD) for continued water service to existing residences. The properties are located in the Buckeye vicinity of Georgetown, near the intersections of Wentworth Springs Road with Breedlove and Brauer Roads.

Recommended Action: Adoption of the environmental review and approval of the annexation.
