7. PUBLIC HEARING TO CONSIDER AND ADOPT THE ENVIRONMENTAL REVIEW AND THE MUNICIPAL SERVICES REVIEW AND SPHERE OF INFLUENCE UPDATE FOR THE LAKEVIEW COMMUNITY SERVICES DISTRICT (LAFCO PROJECT NO. 2017-06)

Informational study on the Lakeview Community Services District and an analysis of its service provision capabilities. The recommended sphere of influence, based on the findings of the MSR, is also included in the report. The Commission considered a draft version of the report and opened the public comment period at the December 5, 2018 meeting.

Recommended Action: Open the public hearing and adopt the recommended SOI.

8. CONSIDER AND APPROVE LAFCO RESOLUTION L-2019-04 RE-SETTING THE LAFCO SALARIES FOR ALL POSITIONS

The Commission found that all staff positions were undercompensated in comparison to similar positions within the local sibling agencies. As a result, it approved raising the compensation but on a phased approach. This is the second of three planned raises to staff to bring up the compensation levels for all staff near market rate. If approved, this resolution supersedes Resolution L-2018-07.

Recommended Action: Open the public hearing on this matter and approve Resolution L-2019-04.

9. PUBLIC HEARING TO CONSIDER AND ADOPT THE PROPOSED WORK PLAN FOR FISCAL YEAR 2019-20

Public hearing to consider and adopt the proposed LAFCO Work Plan for Fiscal Year 2019-20. The Budget Ad Hoc Committee recommends this Work Plan detailing the staff priorities for the coming fiscal year.

Recommended Action: Open public hearing on the matter and adopt the work plan.
