Mr. Henríquez reviewed the staff report with the recommendation that the Commission receive the information on Principal LAFCO status for petitions that involve actions across county lines.

The Commission discussed the application of the "Principal County" and "Principal LAFCO" statutes on various scenarios.

9. CONTINUED DISCUSSION ON THE GEORGETOWN DIVIDE PUBLIC UTILITY DISTRICT MUNICIPAL SERVICE REVIEW AND SPHERE OF INFLUENCE STUDY AND PROVIDE DIRECTION TO STAFF

Mrs. Sanchez reviewed the staff report with the recommendation that the Commission receive the information regarding Municipal Service Reviews and Sphere of Influence Studies (MSR/SOIs) and provide direction to staff on how to proceed with the next GDPUD MSR/SOI, in the following areas:

- 1. A timeline for GDPUD's next MSR/SOI, if it differs from the Third Cycle MSR Project Plan that was adopted at the February 27, 2013 meeting; and
- 2. The scope of analysis and inclusion of any specific issues the Commission would like to see covered in GDPUD's next MSR/SOI, if it differs from the most recent Commission direction.

Chair Mette opened the public forum.

Bonnie McLane, a member of the Georgetown Divide PUD Board of Directors, stated she requested the item for discussion. She indicated she liked the concept of the MSR and was unaware that one had been prepared because the District's staff had not notified the GDPUD Board at the time.
