Continued public hearing to consider and adopt the Mitigated Negative Declaration and exemption under CEQA Guidelines §15183(a) for, and annexation of, the Clarksville Professional Business Park to the El Dorado Irrigation District; LAFCO Project No. 2009-01. The annexation includes two parcels; 121-280-03 (9.5 acres) proposed for approximately ten commercial office/medical buildings and the Clarksville Cemetery, 121-280-05 (1.8 acres). The properties are located south of Highway 50 north of White Rock Road in the El Dorado Hills area. This item was continued from the February 24th Meeting.

Recommended Action: Open the public comment period and approve the annexation as recommended by staff.
