San Diego LAFCO will be seeking to sponsor legislation that would specify that LAFCOs have exclusive jurisdiction to determine whether a service extension is exempt under Government Code 56133(e). San Diego LAFCO is asking is sibling LAFCOs to support this proposal. It is likely that the language would closely mirror what is currently found in your Commission's Policies & Guidelines.

Recommended Action: Support the initiative in concept. Staff will relay the support is on a preliminary basis. Full support is held back pending a review of the final bill language.
